**BY-LAW NO. 2013-#1**

**FORT NELSON FIRST NATION RATES BY-LAW**

WHEREAS pursuant to the *Indian Act*, R.S.C. 1985, and specifically paragraph 83(1)(a) of the *Indian Act*, 1985, c. I-5, the Council of a band may make bylaws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matters arising out of or ancillary to such purpose;

AND WHEREAS the Council of the Fort Nelson First Nation (also known as the Fort Nelson Indian Band) enacted the *Fort Nelson Indian Band Property Taxation Bylaw* on April 27<sup>th</sup>, 1994;

NOW BE IT HEREBY RESOLVED that the following bylaw be and is hereby enacted pursuant to the provisions of the *Indian Act*, and in particular section 83(1) for the purpose of establishing annual rates of taxation.

1. This by-law may be cited for all purposes as the Fort Nelson First Nation Rates By-law 2013.
2. Pursuant to Section 18.1 of the *Fort Nelson Indian Band Property Taxation Bylaw*, the tax rates for each class of property shall be in accordance with Schedule "A" which is attached, and forms part of the *Fort Nelson First Nation Rates By-law 2013*.

This by-law is hereby enacted by Council at a duly-convened meeting held on the 2nd day of Dec., 2013.

Rate of Tax applied against each \$1,000.00 of the assessed value of the land and improvements as determined in accordance with Part IV of the <i>Fort Nelson Indian Band Property Taxation Bylaw</i> .

Class 2 – Utilities	38.5
Class 3 – Unmanaged Forest Land	0
Class 4 – Major Industry	34.3
Class 5 – Light Industry	31.6
Class 6 – Business and Other	0
Class 7 – Managed Forest Land	0
Class 8 – Recreation/Non-Profit Organization	0
Class 9 – Farm	0
