DO HEREBY RESOLVE:

WHEREAS pursuant to subsection 83(1)(a) of the Indian Act, R.S.C. 1985, c.1-5, the Council of a band may make by-laws for the purpose of taxation for local purposes of land, or interests in land, including right to occupy, possess or use land in a reserve and with respect to any matters arising out of or ancillary to such purpose.

AND WHEREAS the Council of the Carry The Kettle First Nation enacted the *Carry The Kettle Property Assessment and Taxation By-law* on April 24, 2003;

NOW BE IT THEREBY RESOLVED that the following by-law be and is hereby enacted pursuant to the provisions of the *Indian Act* and in particular section 83(1) for the purpose of establishing annual rates of taxation.

- This by-law may be sited for all purposes as the *Carry The Kettle First Nation 2013 Tax Rates By-law*.
- Pursuant to section 11 of the Carry The Kettle Property Assessment and Taxation By-law, The rate of tax applied against the assessed value of property for the 2013 tax year shall be

- (a) for pipelines 1.67%
- (b) for commercial & industrial resource 2.30%

This by-law is hereby enacted by Council at a duly convened meeting held on August 27, 2013.
