BY-LAW TO AMEND THE PENTICTON INDIAN BAND TAXATION EXPENDITURE BY-LAW, 2007, PASSED BY CHIEF AND COUNCIL THE 19TH DAY OF JUNE 2007 AND BY THE MINISTER OF INDIAN AFFAIRS AND NORTHERN DEVELOPMENT ON THE 1ST DAY OF FEBRUARY, 2008.

WHEREAS:

The *Penticton Indian Band Expenditure By-law*, 2007 was passed by Chief and Council of the Penticton Indian Band in the best interest of the Band, as a by-law in accordance with section 83(2) of the *Indian Act* for the purpose of the expenditure of monies collected by the Penticton Indian Band pursuant to *Penticton Indian Band Property Assessment and Taxation* enabling by-laws as approved by the Minister, in accordance with section 83(1) of the *Indian Act*; and

WHEREAS:

Pursuant to Section 3.2 of the *Penticton Indian Band Taxation Expenditure By-law 2007*, on or before June 30 of each Fiscal Year, the Penticton Indian Band Council will prepare the Annual Budget and will, by By-law, add the Annual Budget as a schedule to the enacted Expenditure By-law; and

NOW THEREFORE BE IT HEREBY RESOLVED THAT:

The Penticton Indian Band Council enacts the following amending By-law.

Short Title

This amending by-law may be cited as the "Expenditure By-law Annual Budget 2013".

1. That the following Schedule Expenditure By-law Annual Budget 2013 shall be added to the *Penticton Indian Band Taxation Expenditure By-law 2007;*
