TAXATION BY-LAW

TL'AZT'EN NATION 2006 EXPENDITURE BY-LAW

WHEREAS pursuant to subsection 83(1)(a) of the *Indian Act*, the Council of a band may make bylaws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matter arising out of or ancillary to such purpose; and

WHEREAS the Council of the TL'azt'en Nation enacted the TL'azt'en Nation Property Assessment and Taxation By-law on the 25th day of October 1996;

NOW BE IT HEREBY RESOLVED that the following by-law be and is hereby enacted pursuant to the provisions of the *Indian Act* and in particular Section 55(3) and Section 56 for the purpose of the application of taxation revenues.



1. This bylaw may be cited for all purposes as the TL'azt'en Nation 2006 Expenditure By-law.
2. Pursuant to Section 55 and 56 of the TL'azt'en Nation Property Assessment and Taxation By-law, the expenditures of taxation revenues are as follows:
 - (a) the administration of the TL'azt'en Nation Property Assessment and Taxation By-law, \$2,000.00;
 - (b) the remuneration of British Columbia Assessment Authority, \$974.24

This by-law is hereby enacted by Council at a duly convened meeting held in Tache, B.C. on the 28th day of June, 2006.


