WHEREAS a quorum of Chief and Council met at a duly convened meeting on Wednesday, March 23, 2005,

AND WHEREAS pursuant to the Indian Act and their inherent right to self-government, the Council is empowered to act on behalf of the Alexis Nakota Sioux Nation (formerly Alexis First Nation);

AND WHEREAS pursuant to subsection 83(1) (a) of the Indian Act, R.S.C. 1985, c-1-5, the Council of a band may make bylaws for the purpose of taxation for local purposes of land, or interest in land, including rights to occupy, possess or use land in a reserve and with respect to any matters arising our of or ancillary to such purpose:

AND WHEREAS the Council of the Alexis Nakota Sioux Nation enacted the Alexis First Nation Property Tax Bylaw on July 27, 1999

THEREFORE BE IT RESOLVED: that the following bylaw be and is hereby enacted pursuant to the provision of the Indian Act and in particular section 83(1) for the purpose of establishing annual rates of taxation.

- This bylaw may be cited for all purposes as the Alexis Nakota Sioux Nation 2005 tax Rates Bylaw.
- Pursuant to section 5 of the Alexis Nakota Sioux Nation Property Tax Bylaw, the rate of tax applied against the assessed value of property for the 2005 tax year shall be:
