

**SPUZZUM INDIAN BAND
1996 PROPERTY RATES BY-LAW**

WHEREAS:

In 1992, the Spuzzum Indian Band Assessment By-law, and the Taxation By-law, were passed pursuant to Section 83 of the *Indian Act*.

AND WHEREAS:

It is necessary to adopt a further by-law for the purposes of implementing the Spuzzum Indian Band's taxation system.

BE IT HEREBY RESOLVED:

That the Chief and Council of the Spuzzum Indian Band enacts the following By-law pursuant to the *Indian Act*, and in particular Section 83(1) (a), (a.1), and (g) of the *Indian Act*.

SHORT TITLE

This by-law may be cited as the 1996 Property Rates By-law.

Pursuant to the Spuzzum Indian Band Property Taxation By-law the tax rates for each class of property shall be in accordance with Schedule "A" which is attached to and forms part of this By-law.
