WHEREAS section 83(1) of the Indian Act confirms the power of the Band Council to enact bylaws in respect of the taxation for local purposes of reserve lands:

AND WHEREAS the Band Council of the Lower Nicola Indian Band approved a Property Assessment Bylaw at a duly convened meeting of the Band Council on October 27, 1993, as amended (the "Property Assessment Bylaw") to establish by bylaw a system for the assessment of property for the purposes of taxation of land, or interests in land, in the reserve, including rights to occupy, possess, or use the land in the reserve:

AND WHEREAS it is considered to be expedient and necessary that the following Amending Bylaw be enacted for the purposes of updating and correcting the Property Assessment Bylaw as more particularly described below:

NOW BE IT HEREBY RESOLVED that the Band Council of the Lower Nicola Indian Band hereby makes the following Amending Bylaw to the Property Assessment Bylaw:

Short Title

- 1 This Amending Bylaw of the Property Assessment may be cited as " Bylaw Number 12 "

Actual Value

- 2 Subsection 26(1) of the Property Assessment Bylaw is hereby amended by deleting it in its entirety and inserting the following in its place


26(1) In this Bylaw "actual value" means the market value of the fee simple interest in land and improvements as if the interest holder held a fee simple interest located off reserve.

Coming Into Force of Amendment and Application

- 3 This Property Assessment Bylaw Amendment will come into force and effect upon approval by the Minister, and shall be applicable to the 2000 property taxation year and each subsequent taxation year thereafter






