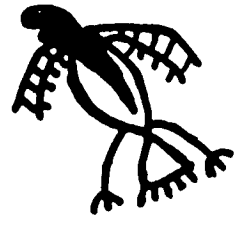

**WHEREAS: The Neskonlith Indian Band Council Does Hereby Resolve:**  
**WHEREAS**

In 1993, the Neskonlith Indian Band Assessment By-law, and the Taxation By-law, were passed pursuant to Section 83 of the *Indian Act*

**AND WHEREAS**

It is necessary to adopt a further by-law for the purposes of implementing the Neskonlith Indian Band's taxation system

**BE IT HEREBY RESOLVED**

That the Chief and Council of the Neskonlith Indian Band enacts the following By-law pursuant to the *Indian Act*, and in particular Section 83(1) (a), (a 1), and (g) of the *Indian Act*

**1 SHORT TITLE**

This by-law may be cited as the 1996 Property Rates By-law

2 Pursuant to the Neskonlith Indian Band Property Taxation By-law the tax rates for each class of property shall be in accordance with Schedule "A" which is attached to and forms part of this By-law
