# 2003 Property Taxation Rates Bylaw Bylaw No. - 2003- 01

#### WHEREAS:

In 1990, the Kamloops Indian Band Assessment Bylaw was passed pursuant to Section 83 of the *Indian Act*.

#### **AND WHEREAS:**

The Kamloops Indian Band has passed the Taxation Amendment Bylaw, the Property Rates, Classification and Miscellaneous Amendment Bylaw, and various other bylaws related to the assessment and taxation within the reserves, pursuant to Section 83 of the *Indian Act*.

#### NOW THEREFORE BE IT HEREBY RESOLVED:

That the Chief and Council of the Kamloops Indian Band enacts the following Bylaw pursuant to the *Indian Act*, and in particular Section 83 (1), (a), (a.1), and (g) of the *Indian Act*.

#### 1. SHORT TITLE

This Bylaw may be cited as the 2003 Property Rates Bylaw.

2. Pursuant to Section 7 of the *Kamloops Indian Band Property Taxation Bylaw*, the tax rates for each class of property shall be in accordance with the attachments to and forms part of the Bylaw.
