The Kamloops Indian Band Council does hereby resolve that:

WHEREAS in 1990, the Kamloops Indian Band Assessment By-law, were passed pursuant to Section 82 of the *Indian Act*.

AND WHEREAS the Kamloops Indian Band has passed the Taxation Amendment By-law, the Property Rates, Classification and Miscellaneous Amendment By-law, and various other by-laws related to the assessment and taxation of land within the reserves, pursuant to Section 83 of the *Indian Act*.

BE IT HEREBY RESOLVED:

That the Chief and Council of the Kamloops Indian Band enacts the following By-law pursuant to the *Indian Act*, and in particular Section 83(1), (a), (a.1) and (g) of the *Indian Act*.

1. SHORT TITLE

This By-law may be cited as the 1996 Property Rates By-law.

2. Pursuant to Section 7 of the *Kamloops Indian Band Property Taxation By-law*, the tax rates for each class of property shall be in accordance with Schedule "A" which is attached to and forms part of the By-law.
