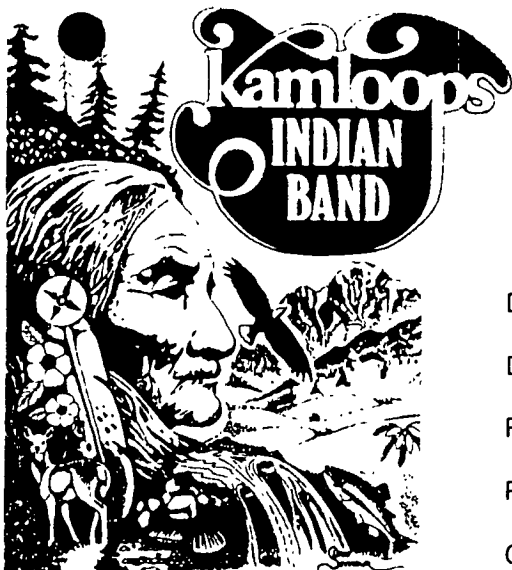

The Kamloops Indian Band Council does hereby resolve that:

WHEREAS:

The Kamloops Indian Band has passed the Assessment Bylaw, the Taxation Bylaw and the Taxation Expenditure Bylaw, all of which were approved by the Minister of Indian Affairs in 1990, pursuant to Section 83 of the Indian Act.

AND WHEREAS:

The Kamloops Indian Band Intends to implement the aforesaid Bylaws during the calendar year 1991.

AND WHEREAS:

It is necessary to make certain amendments to the time periods set out in the aforesaid Bylaws to achieve their purposes, which amendments will be in force and effect during the calendar year 1991 only.

BE IT HEREBY RESOLVED:

That the Chief & Council of the Kamloops Indian Band enacts the following Bylaw pursuant to the Indian Act, and in particular to Section 83 (1)(a), (b), (c), (e) and (g) of the Indian Act.

1. SHORT TITLE:

This Bylaw may be cited as the Taxation Amendment Bylaw.

2. Kamloops Indian Band Property Assessment Bylaw

(a) The Kamloops Indian Band Property Assessment Bylaw (the "Assessment Bylaw") is hereby amended to add the following phrase after each date set out therein:

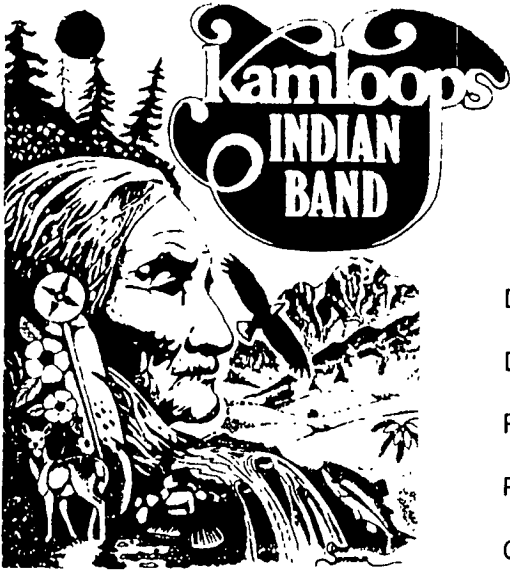

- (b) Where in the Assessment Bylaw the time for doing anything is expressed as a certain number of days following an event, the time period shall be adjusted in accordance with the amendment set out in Section 2(a) hereof, mutetis mutandis.

3. Kamloops Indian Band Property Taxation Bylaw

- (a) The Kamloops Indian Band Property Taxation Bylaw (the "Taxation Bylaw") is hereby amended to add the following phrase after each date set out therein:

"or at the latest on or before September 1, 1991, for the taxation year 1991 only".

- (b) Wherein the Taxation Bylaw the time for doing anything is expressed as a certain number of days following an event, the time period shall be adjusted in accordance with the amendment set out in Section 3(a) hereof, mutatis mutandis.

4. Kamloops Indian Band Taxation Expenditure Bylaw

- (a) The Kamloops Indian Band Taxation Expenditure Bylaw (the "Expenditure Bylaw") is hereby amended to add the following phrase after each date set out therein:

"or at the latest, on or before May 1, 1991, for the taxation year 1991 only".

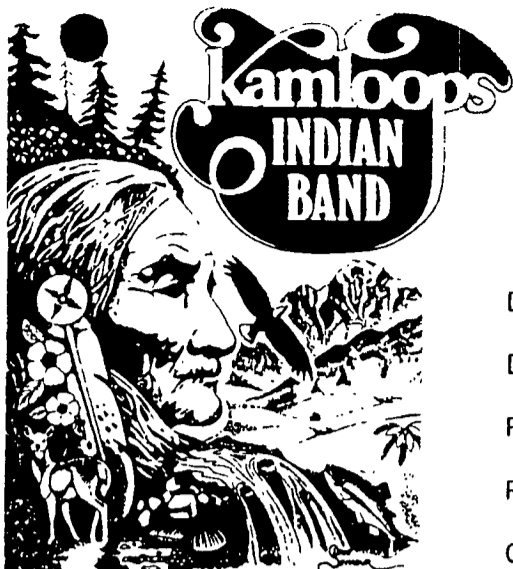
