**ASHCROFT INDIAN BAND  
1997 PROPERTY RATES BY-LAW**

**WHEREAS:**

In 1993, the Ashcroft Indian Band Assessment By-law, and the Taxation By-law, were passed pursuant to Section 83 of the *Indian Act*, and were approved by the Minister of Indian Affairs and Northern Development in 1993;

**AND WHEREAS:**

It is necessary to adopt a further by-law for the purposes of implementing the Ashcroft Indian Band's taxation system.

**BE IT HEREBY RESOLVED:**

That the Chief and Council of the Ashcroft Indian Band enacts the following By-law pursuant to the *Indian Act*, and in particular Section 83(1) (a), (a.1), and (g) of the *Indian Act*.

**SHORT TITLE**

This by-law may be cited as the 1997 Property Rates By-law.

Pursuant to the Ashcroft Indian Band Property Taxation By-law the tax rates for each class of property shall be in accordance with Schedule "A" which is attached to and forms part of this By-law.

And Whereas the rates in the bylaw were set in accordance with the rates prevailing in the adjacent village of Ashcroft,

And Whereas those rates are substantially lower than the Bands rates for the 1996 taxation year,

And Whereas the village of Ashcroft has lowered its rates for reasons which are not relevant to the situation on our reserves,

And Whereas we now consider that it is not in the best interests of the Band to lower the Property Tax Rates from those which were set in 1996,

Now Therefore be it resolved that the Ashcroft Indian Band 1997 Property Rates By-law dated September 26, 1997 is now rescinded and replaced with the Ashcroft Indian Band 1997 Rates By-law dated December 1, 1997
