Songhees First Nation Property Tax Expenditure Bylaw No. 2007-01

WHEREAS pursuant to subsection 83(1)(a) of the Indian Act, the Council of a band may make bylaws for the purpose of taxation for local purposes of land, or interest in land, including rights to occupy, possess or use land in a reserve and with respect to any matter arising out of or ancillary to such purpose;

AND WHEREAS subsection 83(2) of the Indian Act provides that an expenditure made out of moneys raised pursuant to subsection 83(1) of the Indian Act must be so made under the authority of a bylaw of the council of the band;

AND WHEREAS section 12 of the Songhees Indian Band Property Taxation Bylaw, PR-95-02 authorizes the making of certain expenditures out of the property tax revenue.

NOW BE IT HEREBY RESOLVED that the following bylaw be and is hereby enacted pursuant to the provisions of the Indian Act and in particular subsections 83(1) and (2) thereof, for the purpose of authorizing expenditures to be made out of property tax revenue.

Pursuant to Sections 12(3) and 12(4) of the Songhees Indian Band Property Taxation Bylaw, PR-95-02 the Expenditure Budget for 2007 shall be in accordance with Schedule "A" which is attached and forms part of the 2007 Songhees First Nation Property Tax Expenditure Bylaw No. 2007-01.

This bylaw is hereby enacted by Council at a duly convened meeting held on the 8th day of March 2007.
