A Bylaw to Fix Tax Rate for the Year 2001

WHEREAS:

A. The Cowichan Indian Band "Property Assessment and Taxation Bylaw" was enacted pursuant to Subsection 83(1) of the <u>Indian Act</u> for the purpose of taxation for local purposes of land, or interests in land, in the "reserve" (as defined in the Property Assessment and Taxation Bylaw) including rights to occupy, possess or use land in the "reserve".

NOW BE IT HEREBY RESOLVED THAT the following bylaw be and is hereby enacted pursuant to the provisions of the <u>Indian Act</u> and in particular Subsection 83(1) thereof, for the purpose of fixing a tax rate for the year 2001.
