# NADLEH WHUT'EN INDIAN BAND 1999 RATES AMENDING BYLAW

WHEREAS pursuant to subsection 83(1)(a) of the Indian Act, R.S.C. 1985, c. I-5, the Council of a band may make bylaws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matters rising out of or ancillary to such purpose;

AND WHEREAS the Council of the Nadleh Whut'en Indian Band, enacted the Nadleh Whut'en Indian Band 1999 Rates Bylaw, By-law 1998-7 on December 18, 1998;

NOW BE IT HEREBY RESOLVED that the following bylaw be and is hereby enacted pursuant to the provisions of the Indian Act and in particular section 83(1) for the purpose of amending the Nadleh Whut'en Indian Band 1999 Rates Bylaw, Bylaw No. 1996-7.

### SHORT TITLE

- 1. This bylaw may be cited as the Nadleh Whut'en Indian Band 1999 Rates Bylaw Amending Bylaw.
- 2. Schedule "A" of the Nadleh Whut'en Indian Band 1999 Rates Bylaw is amended by deleting it and substituting the following:
