## LHEIDLI T'ENNEH BAND BYLAW NO. 2004 - TX 01

WHEREAS pursuant to subsection 83(1) of the *Indian Act*, the Council of a Band may make bylaws for the purpose of taxation for local purposes of land, or interest in land including the rights to occupy, possess or use lands within the boundaries of the Reserve and with respect to any matters arising out of or ancillary to such purpose:

AND WHEREAS the Council of the Lheidli T'enneh Band enacted the Lheidli T'enneh Band Taxation and Assessment Bylaws on September 23, 1992;

**NOW BE IT HEREBY RESOLVED** that the following bylaw be and is hereby enacted pursuant to the provisions of the *Indian Ac* t and in particular subsection 83(1) for the purpose of establishing annual rates of taxation.

- 11. This byław may be cited for all puposes as the Lheidli Tenneh Band 2004 Rates Byław.
- 2. Pursuant to Section 24 of the Lheidli T'enneh Band Taxation Bylaw, the rates for each class of property shall be in accordance with Schedule "A" which is attached, and forms part of the 2004 Rates Bylaw.

This bylaw is hereby enacted by the Council of the Lheidli Tenneh Band at a duly convened meeting held on the 15 day of November, 2004.
