**COLUMBIA LAKE INDIAN BAND  
BYLAW NO.2001-TX01**

**WHEREAS** pursuant to subsection 83(1) of the *Indian Act*, the Council of a Band may make bylaws for the purposes of taxation for local purposes of land, or interest in land including the rights to occupy, possess or use lands within the boundaries of the Reserve and with respect to any matters arising out of or any ancillary to such purpose:


**AND WHEREAS** the Council of the Columbia Lake Indian Band enacted the Columbia Lake Indian Band Taxation and Assessment Bylaw on March 9, 1992;


**NOW BE IT THEREFORE RESOLVED** that the following bylaw be and is hereby enacted pursuant to the provisions of the *Indian Act* and in particular section 83(1) for the purpose of establishing annual rates of taxation.

1. This bylaw may be cited for all purposes as the Columbia Lake Indian Band 2001 Rates Bylaw.
2. Pursuant to section 24 of the Columbia Lake Indian Band Taxation Bylaw, the rates for each class of property shall be in accordance with Schedule "A" which is attached and forms part of the 2001 Rates Bylaw.


This bylaw is hereby enacted by the Council of the Columbia Lake Indian Band at a duly convened meeting held on the 2nd day of April 2001.
