

A BYLAW TO AMEND THE WESTBANK FIRST NATION TAXATION EXPENDITURE BYLAW, 1995, PASSED BY CHIEF AND COUNCIL THE 6TH DAY OF JUNE 1995 AND BY THE MINISTER THE 24TH DAY OF OCTOBER, 1995.

WHEREAS:

the Westbank First Nation Taxation Expenditure Bylaw, 1995 was passed by Chief and Council of the Westbank First Nation in the best interest of the Band, as a bylaw in accordance with section 83(2) of the Indian Act for the purpose of the expenditure of monies collected by the Westbank First Nation pursuant to Westbank First Nation Property Assessment and Taxation enabling bylaws as approved by the Minister, in accordance with section 83(1) of the Indian Act ; and

WHEREAS:

pursuant to Section 3.2 of the Westbank First Nation Taxation Expenditure Bylaw 1995, on or before June 30 of each Fiscal Year, the Band Council will prepare the Annual Budget and will by bylaw add the Annual Budget as a schedule to the enacted Expenditure Bylaw; and

NOW THEREFORE BE IT HEREBY RESOLVED THAT:


the Chief and Council of the Westbank First Nation enacts as an amending Bylaw;

This amending bylaw may be cited as the "1997 Expenditure Bylaw Annual Budget".
