By-Law No. 25 1993-03

A BY-LAW TO AMEND THE WESTBANK INDIAN BAND TAXATION EXPENDITURE BY-LAW 1991, PASSED BY CHIEF AND COUNCIL THE 21ST DAY OF NOVEMBER 1991 AND APPROVED BY THE MINISTER THE 5TH DAY OF FEBRUARY 1992.

WHEREAS the Westbank Indian Band passed the Taxation By-law and Taxation Assessment By-law pursuant to the provisions of the <u>Indian</u> <u>Act</u> and in particular pursuant to subsection 83(1) of the <u>Indian</u> <u>Act</u>;

AND WHEREAS the Council of the Westbank Indian Band did enact By-law No. 1991 for the purposes of expending taxation monies collected under the Westbank Indian Band Taxation By-law 1991 for the 1991 and subsequent taxation years for the fair and equitable taxation for local purposes of land, or interests in land, in the reserve, including rights to occupy, possess or use land, in the reserve;

AND WHEREAS pursuant to the Westbank Indian band Taxation Expenditure By-law 1991 section 3(1) on or before April 15th in each fiscal year, the Band Council shall prepare the annual budget and section 5(1). The Chief and Council may, by Band Council resolution, extend for a maximum of 90 days the time which anything is required to be done under this By-law;

AND WHEREAS the said Council deems it advisable and in the best interests of the residents of IR#9 and IR#10 to amend the Westbank Indian Band Expenditure By-law 1991;

NOW THEREFORE the Council of the Westbank Indian Band enacts as an amending By-Law thereof as follows:

1. That Schedule "C" EXPENDITURE BY-LAW BUDGET 1993 is hereby added as a further schedule to the Westbank Indian Band Expenditure By-Law 1991.
