The words "from our Band Funds" "capital" or "revenue", whichever is the case, must appear in all resolutions requesting expenditures from Band Funds.

WHEREAS:

Pursuant to subsection 83(1)(a) of the *Indian Act*, R.S.C. 1985, c.I-5, the Council of a band may make bylaws for the purpose of taxation for local purposes of land, or interest inland, including rights to occupy, possess or use land in a reserve and with respect to any matters rising out of or ancillary to such a purpose;

AND WHEREAS:

The Council of the Lower Similkameen Indian Band enact the Lower Similkameen Property Assessment and Taxation Bylaw on May 31, 1996;

NOW BE IT RESOLVED:

That the following bylaw be and is hereby enacted pursuant to the provisions of the *Indian Act* and in particular section 83(1) for the purpose of establishing annual rates of taxation.

- 1. This bylaw may be cited as the Lower Similkameen Indian Band 2000 Rates Bylaw.
- 2. Pursuant to Section 11 of the Lower Similkameen Indian Band Property Assessment and Taxation Bylaw, the tax rates for each class property shall be in accordance with Schedule "A: which is attached, and forms part of the 2000 Rates Bylaw.

This Bylaw is hereby enacted by Council at a duly convened meeting held on the 1st day of December, 2000.
