Bylaw No. 11-TX-02 of the Penticton Indian Band

WHEREAS:

The Chief and Council of the Penticton Indian Band deems it advisable and in the best interests of the members of the Penticton Indian Band to amend the Property Taxation Bylaw 07-TX-02 passed by Chief and Council June 19th, 2007 and approved by the Minister February 01, 2008, that being a bylaw to establish by a system on the reserve land of the Penticton Indian Band for taxation purposes of land, or interests in land, in the reserve, including rights to occupy, possess or use land in the reserve; and

WHEREAS:

Pursuant to Section 18.1(3) of the Penticton Indian Band Property Taxation Bylaw 07-TX-02, Chief and Council shall prescribe tax rates; and

WHEREAS:

Those rates prescribed by the Chief and Council are set out in schedule to the Penticton Indian Band Property Taxation Bylaw 07-TX-02 pursuant to section 18.1(4); and

NOW THEREFORE BE IT HEREBY RESOLVED THAT:

The Penticton Indian Band Council enacts as an amending Bylaw;

Short Title

This amending bylaw may be cited as the "2011 Tax Rate Schedule Amending Bylaw".
