




3. As soon as practicable on or after the 4th of July, 2000 the Surveyor of Taxes of the
Osoyoos Indian Band shall add to the current year's taxes unpaid as at 4:30 P.M. on the 4th day
of July, 2001, on each parcel of land on his Roll, ten per cent (10%) of the amount thereof and
the said unpaid taxes, together with amounts added as aforesaid shall from the 4th day of July,
2001, be deemed to be the amount of the current year's taxes upon such land.
