

DO HEREBY RESOLVE:
 DÉCIDE, PAR LES PRÉSENTES:

Whereas the Osoyoos Indian Band has passed and have had approved its Property Taxation By-law, dated December 2, 1994, and

Whereas: The Chief and Council of the Osoyoos Indian Band deem it advisable and in the best interests of the Band to engage in the taxation for local purposes of land, or interests in land, in the reserve lands of the Osoyoos Indian Band, including the rights to occupy, possess, or use land in the reserve, and

Whereas: It is necessary for the levying of tax to establish rates on land and improvements for Band Government, municipal, hospital, and regional district purposes for the year 1996;

The Chief and Council of the Osoyoos Indian Band hereby enacts as follows:

1. The following rates are hereby imposed and levied on the various classes of property for the year 1996, applicable to the whole of Osoyoos Indian Reserves:

2. The minimum amount of taxation upon a parcel of real property shall be \$ 350.00.

3. As soon as practicable on or after the 30th day of August, 1996, the Surveyor of Taxes of the Osoyoos Indian Band shall add to the current year's taxes unpaid as at 4:30 p.m. on the 30th day of August, 1996, on each parcel of land on his Roll, ten per centum (10%) of the amount thereof and the said unpaid taxes, together with amounts added as aforesaid shall from the 30th day of August, 1996, be deemed to be the amount of the current year's taxes upon such land.

This bylaw may be cited as "Tax Rates By-law No. 001, 1996".
