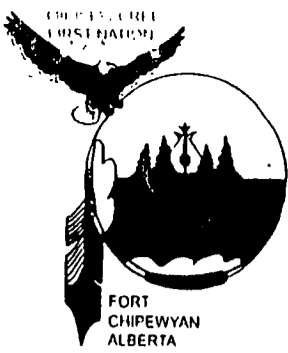

**WHEREAS:** The Mikisew Cree First Nation Chief and Council have been elected to represent and empowered to act on behalf of the constituents of Mikisew Cree First Nation; and

**WHEREAS:** The Powers and Authorities of the Council are exercised as provided for under the Indian Act; and

**WHEREAS:** The liabilities of Council are limited to those specifically provided for under the Indian Act; and

**WHEREAS:** Pursuant to subsection 83(1) (a) of the *Indian Act*, R.S.C. 1985, c. I-5, the Council of a band may make by-laws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matters arising out of or ancillary to such purpose;

**AND WHEREAS:** The Council of the Mikisew Cree First Nation enacted the Mikisew Cree First Nation Property Assessment and Taxation By-Law on June 24, 1997;

**NOW BE IT THEREBY RESOLVED:**

The following by-law be and is hereby enacted pursuant to the provisions of the *Indian Act* and in particular section 83(1) for the purpose of establishing annual rates of taxation.

1. This by-law may be cited for all purposes as the Mikisew Cree First Nation 2003 Tax Rates By-Law.
2. Pursuant to section 11 of the Mikisew Cree First Nation Property Assessments and Taxation By-Law, the rate of tax applied against the assessed value of the land and improvements for tax year 2003 shall be 1.50%

This bylaw is hereby enacted by Council at a duly convened meeting held on March 11, 2003.


