

- WHEREAS:** The Mikisew Cree First Nation ("MCFN") Chief and Council have been elected to represent and empowered to act on behalf of the constituents of Mikisew Cree First Nation; and
- WHEREAS:** The Powers and Authorities of the council are exercised as provided for under the Indian Act; and
- WHEREAS:** The liabilities of Council and limited to those specifically provided for under the Indian Act; and
- WHEREAS:** This Council has met at the duly convened meeting on June 07, 1999; and
- WHEREAS:** Pursuant to subsection 83(1)(a) of the *Indian Act*, R.S.C 1985, c.1-5, the Council of a band may make bylaws for the purpose of taxation for local purposes of land, or interest in land, including rights to occupy, possess or use land in a reserve and with respect to any matters rising out of or ancillary to such purpose;
- WHEREAS:** The Council of the Mikisew Cree First Nation enacted the Mikisew Cree First Nation Property Assessment and Taxation Bylaw on June 24, 1997;

**THEREFORE BE IT RESOLVED THAT:**

The following bylaw be and is hereby enacted pursuant to the provisions of the *Indian Act* and in particular section 83(1) for the purpose of establishing annual rates of taxation.

1. This bylaw may be cited for all purposes as the Mikisew Cree First Nation 1999 Rates Bylaw.
2. Pursuant to section 11 of the Mikisew Cree First Nation Property Assessment and Taxation Bylaw, the rate of tax applied against the assessment value of the land and improvements shall be 1.45%

This bylaw is hereby enacted by Council at a duly convened meeting held on the 7<sup>th</sup> day of June, 1999.

The quorum for this First Nation consists of Four (4) Council members.
