Whitefish Lake First Nation Property Tax Bylaw Amendment

WHEREAS pursuant to subsection 83(1)(a) of the Indian Act R.S.C. 1985 c.1-5 the Council of a band may make bylaws for the purpose of taxation for local purposes of land, or interest in land, including rights to occupy, possess or use land in a reserve and with respect to any matters rising out of or ancillary to such purpose;

and

WHEREAS the Council of the Whitefish Lake First Nation enacted the Whitefish Lake First Nation Property Tax Bylaw on December 4, 1998; and

WHEREAS the Council of the Whitefish Lake First Nation deem it advisable to amend the Bylaw to provide a time frame for taxation in the 1999 tax year;

THEREFORE BE IT RESOLVED that the Council of the Whitefish Lake First Nation enacts the following amendments to the Whitefish Lake First Nation Property Tax Bylaw,

- 1. Section 5.2 is amended by adding at the end of the section:, except for the 1999 taxation year in which taxes are due as of September 30.
- 2. Section 7.3.1 is amended by striking out 'May 1' and replacing it with September 1.
- 3. Section 8.1 is amended by striking out 'May 1' and replacing it with September 1.
- 4. Section 12.1 is amended by adding at the end of the section:, except for the 1999 taxation year in which taxes are due and payable as of September 30.

This bylaw is hereby enacted by Council at a duly convened meeting held on the 9th day of August 1999.
