I-5, the Chief and Council of the Nation may make by-laws for the purpose of taxation for local purposes of the land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matter arising out of or ancillary to such purpose; and										
WHEREAS, the Chief and Council of Bigstone Cree First Nation enacted the Bigstone Cree First Nation Property Assessment and Taxation By-Law on April 15, 2004;										
THEREFORE BE IT RESOLVED, that the following by-law be and is hereby enacted pursuant to the provisions of the <i>Indian Act</i> and in particular section 83(1) for the purpose of establishing annual rates of taxation.
