DO HEREBY RESOLVE:

WHEREAS a quorum of Chief and Council met at a duly convened meeting on Wednesday, April 14, 2004

WHEREAS pursuant to subsection 83(1) (a) of the Indian Act, R.S.C. 1985, c 1-5, the Council of a band may make by-laws for purposes for local purposes of land or interests in land, including rights to occupy, possess or use land in a reserved with respect to any matters arising out of or ancillary to such purpose; and

WHEREAS the Council of the Alexis First Nation enacted the Alexis First Nation Property Tax By-law on July 27, 1999; and

THEREFORE BE IT RESOLVED THAT the following by-law be and is hereby enacted pursuant to the provisions of the Indian Act and in particular section 83(1) for the purpose of establishing annual rates of taxation.

- This bylaw may be cited for all purposes as the Alexis First Nation 2004 Tax Rates Bylaw.
- Pursuant to section 5 of the Alexis First Nation Property Tax By-law, the rate of tax applied against each \$1000.00 of the assessed value of property for the 2004 tax year shall be:

In Reserve No. 133;

- (a) For machinery and equipment 1.50%
- (b) For property other than machinery and equipment 2.20%

In Reserve No. 232;

- (a) For property other than machinery and equipment 1.31%
