DO HEREBY RESOLVE:  
DECIDE, PAR LES PRÉSENTES:

**WHEREAS** pursuant to subsection 83(1)(a) of the *Indian Act*, R.S.C. 1985, c.1-5, the Council of a band may make by-laws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matters arising out of or ancillary to such purpose; and

**WHEREAS** the Council of the Siksika Nation enacted the *Siksika Nation Property Assessment and Taxation By-law* on June 16, 2004;

**THEREFORE BE IT RESOLVED THAT** the following by-law be and is hereby enacted pursuant to the provisions of the *Indian Act* and in particular section 83(1) for the purpose of establishing annual rates of taxation.

- This by-law may be cited for all purposes as the *Siksika Nation 2005 Tax Rates By-law*.
- Pursuant to Section 11 of the *Siksika Nation Property Assessment and Taxation By-law*, the rate of tax applied against the assessed value of property shall be,
 

(a) for non-residential and linear	1.50%
(b) for machinery and equipment	0.85%

This by-law is hereby enacted by Council at a duly convened meeting held on April 19, 2005.
