DÉCIDE, PAR LES PRÉSENTES:

**2010 Property Tax Rates By-law**

**WHEREAS:** pursuant to subsection 83 (1) (a) of the *Indian Act*, R.S.C. 1985, c-1-5, the Council of a band may make by-laws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matter arising out of or ancillary to such purpose;

**AND WHEREAS** the Council of the Carry The Kettle First Nation enacted the *Carry The Kettle Property Assessment and Taxation By-law* on April 24, 2003;

**NOW BE IT THEREBY RESOLVED** that the following by-law be and is hereby enacted pursuant to the provisions of the *Indian Act* and in particular section 83(1) for the purpose of establishing annual rates of taxation.


1. This by-law may be cited for all purposes as the *Carry The Kettle First Nation 2010 Tax Rates By-law*.
2. Pursuant to section 11 of the *Carry The Kettle Property Assessment and Taxation Bylaw*, the rate of tax applied against the assessed value of property for the 2010 tax year shall be 2.38%.

July 15, 2010.
