AND WHEREAS The Council of the Millbrook First Nation, enacted the Land Tax By-law on June 3, 1996.

NOW BE IT HEREBY RESOLVED that the following bylaw is hereby enacted pursuant to the provisions of the *Indian Act* and in particular section 83(1) for the purpose of establishing annual rates of taxation.

- 1. This bylaw may be cited for all purposes as the Millbrook First Nation 2001 Rates Bylaw.
- 2. Pursuant to Section 11 of the Land Tax By-law, the tax rates for each class of property shall be in accordance with Schedule "A" which is attached, and forms part of the 2001 Rates Bylaw.
