SISKA INDIAN BAND

2021 RATES BY-LAW

WHEREAS pursuant to the *Indian Act*, R.S.C. 1985, and specifically paragraph 83(1)(a) of the *Indian Act*, R.S.C. 1985, c.I-5, the Council of a band may make by-laws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matters arising out of or ancillary to such purpose;

AND WHEREAS the Council of the Siska Indian Band has enacted the *Siska Indian Band Taxation By-law* and *Siska Indian Band Assessment By-Law*.

NOW BE IT HEREBY RESOLVED that the following by-law be and is hereby enacted pursuant to the provisions of the *Indian Act*, and in particular, section 83(1) for the purpose of establishing annual rates of taxation.


1. This by-law may be cited for all purposes as the *Siska Indian Band 2021 Rates By-law*.
2. Pursuant to section 24(1) of the *Siska Indian Band Taxation By-Law*, the tax rates for each class of property shall be in accordance with Schedule "A" which is attached, and forms part of the *2021 Rates By-Law*.

THIS BY-LAW IS HEREBY ENACTED by the Council of the Siska Indian Band at a duly convened meeting held on the B day of ~~September~~ 2021.
A quorum of Council consists of 3 members of Council.

SCHEDULE "A"

The Council of the Siska Indian Band hereby adopts the following taxation rates for the 2021 taxation year on the following classes of property.

Column 1	Column 2
Class of property proscribed under Schedule II and Section 11 of the <i>Siska Indian Band Property Taxation By-law</i> .	Rate of tax applied against each \$1,000.00 of the assessed value of the land and improvements as determined in accordance with Part IV of the <i>Siska Indian Band Assessment and Taxation By-Laws</i> .

Class 2 – Utilities	23.01564
Class 10 – CPR Right of Way	17.2882
