WHEREAS the Stoney Tribal Council is empowered to act for and on behalf of the people of the Bearspaw, Chiniki and Wesley Bands; and

WHEREAS pursuant to the *Indian Act*, R.S.C. 1985, and specifically paragraph 83(1)(a) of the *Indian Act*, 1985, c.I-5, the Council of a band may make by-laws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matters arising out of or ancillary to such purpose; and

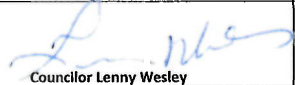
WHEREAS the Council of the Stoney Tribal Administration (also known as the Stoney Band) enacted the *Stoney Property Tax By-law* on July 9, 1991 and approved by the Minister on September 23, 1991;

NOW BE IT HEREBY RESOLVED that the following by-law be and is hereby enacted pursuant to the provisions of the *Indian Act*, and in particular section 83(1) for the purpose of establishing annual rates of taxation.

1. This by-law may be cited for all purposes as the *Stoney Tribal Administration Rates By-law 2018*.
2. Pursuant to Section 11 of the *Stoney Property Tax By-law*, the tax rates for each class of property shall be in accordance with Schedule "A" which is attached, and forms part of the 2018 Rates By-law.

A quorum of Council consists of Nine (9) members of Council.
