## STURGEON LAKE CREE NATION

### RATES BY-LAW 2018

WHEREAS pursuant to the *Indian Act*, R.S.C. 1985, and specifically paragraph 83(1)(a) of the *Indian Act*, 1985, c.I-5, the Council of a band may make by-laws for the purpose of taxation for local purposes of land, or interests in land, including rights to occupy, possess or use land in a reserve and with respect to any matters arising out of or ancillary to such purpose;

AND WHEREAS the Council of the Sturgeon Lake Cree Nation (also known as the Sturgeon Lake Band) enacted the *Sturgeon Lake Band Taxation and Business Licensing By-law* on July 23, 1986 and approved by the Minister on February 17, 1987;

NOW BE IT HEREBY RESOLVED that the following by-law be and is hereby enacted pursuant to the provisions of the *Indian Act*, and in particular section 83(1) for the purpose of establishing annual rates of taxation.


1. This by-law may be cited for all purposes as the *Sturgeon Lake Cree Nation Rates By-law 2018*.
2. Pursuant to Section 21 of the *Sturgeon Lake Band Taxation and Business Licensing By-law*, the tax rates for each class of property shall be in accordance with Schedule "A" which is attached, and forms part of the 2018 Rates By-law.

THIS BY-LAW IS HEREBY DULY ENACTED by Council on the 8 day of May, 2018, at Sturgeon Lake Cree Nation, in the Province of Alberta .

Class of Property as prescribed under Schedule II and Section 21 of the <i>Sturgeon Lake Band Taxation and Business Licensing By-law</i> .	Rate of Tax applied against each \$1,000.00 of the assessed value of the land and improvements as determined in accordance with Part IV of the <i>Sturgeon Lake Band Taxation and Business Licensing By-law</i> .
Class 1 – Residential	
Class 2 – Non-residential and linear property	1.91111%
Class 3 – Farm land	
Class 4 – Machinery and Equipment	1.49475%
