

The Council of the SPANISH RIVER Band of Indians at a meeting held October 19, 1956, makes the following by-law pursuant to paragraphs (c), (d), (q) and (r) of Section 80 of the Indian Act.

By-Law No. 112

A by-law to provide for the regulation of the activities of boys and girls on the SPANISH RIVER Indian Reserve, actually or apparently under 16 years of age.

- (a) No boy or girl on the SPANISH RIVER Indian Reserve actually or apparently under 16 years of age, shall loiter any place within the said Indian Reserve after nine o'clock in the afternoon.
- (b) No boy or girl on the SPANISH RIVER Indian Reserve, actually or apparently under 16 years of age, shall be in any place or entertainment, street, lane, by-way or common within the said reserve, or shall be in the course of returning from any place of entertainment off the said Reserve after the hour of nine o'clock in the afternoon unless accompanied by his or her parent or an adult appointed by a parent to accompany such child.

A boy or girl on the SPANISH RIVER Indian Reserve found violating the provisions of paragraph (a) or (b) may be warned and conducted home by a police officer.

A parent who permits his child to violate paragraph (a) or (b) shall be guilty of an offence and shall be liable on summary conviction to a fine not exceeding \$5.00 or imprisonment for a term not exceeding seven days, or both fine and imprisonment.

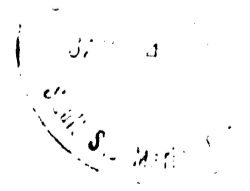

Regulation of Traffic

*Not Documented*

The Council of the Spanish River Band of Indians at a meeting held *September 2nd 1959*... makes the following by-law pursuant to paragraph (b) and (c) of section 80 of The Indian Act.

ByL aw No. *2*.....

A by-law to provide for the regulation of traffic in Spanish River Indian Reserve, in the Province of Ontario.

(a) No vehicle shall be operated at a rate of speed in excess of *30 (Thirty)*..... miles an hour within any residential area designated and marked as such by the Council of the band.

(b) No vehicle shall be operated over any bridge within the Spanish River Indian Reserve at a rate of speed ~~in excess~~ of the speed designated and marked thereon by the council of the band.

(c) Any person who violates any of the provisions of this by-law shall be guilty of an offence and shall be liable on summary conviction to a fine not exceeding ten dollars or imprisonment for a term not exceeding seven days, or both fine and imprisonment.

*(d) no vehicle shall be operated at a rate of speed in excess of 15 (fifteen) miles an hour within any school area.*
