**By-Law No. 2**

Being a By-law to authorize the carrying on of a Community Program of Recreation within the meaning of the Regulations under the Department of Education Act.

1. The Council of the Band enacts as follows;

- (a) Pursuant to Regulations 19/66 made under the Department of Education Act, a Community Program of Recreation is hereby established for the residents of the reserve.
- (b) The said Community Program of Recreation shall be directed managed and controlled on behalf of the Council by a Committee known as the Sheguiandah Band Recreation Committee.

2. The Committee shall be appointed from time to time by the Band Council Resolution as follows:

- (a) 2 members of the Council
- (b) 3 residents of the said Reserve.
