DO HEREBY RESOLVE:

THAT THE FOLLOWING BY-LAW PURSUANT TO PARAGRAPH (G) OF SECTION 80 OF THE INDIAN ACT BE ENACTED TO BE EFFECTIVE FORTY DAYS FROM THIS DATE, FEBRUARY 19, 1969, IN ACCORDANCE WITH PARAGRAPH (2) OF SECTION 81 OF THE INDIAN ACT.

BY-LAW NO. 3 (1)

A BY-LAW TO PROVIDE ZONING REGULATIONS APPLYING TO TWO PORTIONS OF AGENCY RESERVE NO. 1:

- (A) THAT THE LAND LEASED TO THE RAINY LAKE GOLF AND COUNTRY CLUB UNDER LEASE NUMBERS 228 AND 232 BE ZONED AS COMMERCIAL-RECREATIONAL FOR THE BALANCE OF THE PRESENT LEASE PERIOD OR SOONER IF THE LEASE IS TERMINATED.
- (B) THAT THE LAND KNOWN AS PITHERS POINT PARK AND LEASED TO THE FORT FRANCES PARKS BOARD UNDER LEASE NUMBER 231 BE ZONED AS COMMERCIAL-RECREATIONAL FOR THE BALANCE OF THE PRESENT LEASE PERIOD OR SOONER IF THE LEASE IS TERMINATED.

DO HEREBY RESOLVE: THAT OUR BY-LAW NO. 1 SUBMITTED ON BAND COUNCIL RESOLUTION NO. 13/1970-71 OF JUNE 5, 1970 BE WITHDRAWN.

THAT THE COUNCIL OF THE NICICROUSEMENEKANING BAND OF INDIANS AT A MEETING HELD ON JULY 6/70 MAKES THE FOLLOWING BY-LAW PURSUANT TO PARAGRAPH (O) AND (R) OF SECTION 80 OF THE INDIAN ACT.

BY-LAW NO. 1

A BY-LAW TO PROVIDE FOR THE PRESERVATION, PROTECTION AND MANAGEMENT OF FISH AND GAME ON THE RAINY LAKE INDIAN RESERVE NO. 26A, IN THE PROVINCE OF ONTARIO.

- NO PERSON, OTHER THAN A MEMBER OF THE NICICROUSEMENEKANING BAND OF INDIANS, MAY HUNT OR FISH ON THE RAINY LAKE INDIANS RESERVE NO. 26A, UNLESS THAT PERSON IS:
(A) ACCOMPANIED BY, OR (B) HAS EMPLOYED AS A GUIDE, A MEMBER OF THE NICICROUSEMENEKANING BAND.
- NO PERSON SHALL DEFACE, MUTILATE OR DESTROY ANY SIGN OR NOTICE PLACED OR ERECTED BY AUTHORITY OF THE BAND COUNCIL IN RESPECT OF THIS BY-LAW:
- ANY PERSON WHO VIOLATES ANY OF THE PROVISIONS OF THIS BY-LAW SHALL BE GUILTY OF AN OFFENCE AND SHALL BE LIABLE ON SUMMARY CONVICTION TO A FINE NOT EXCEEDING ONE HUNDRED DOLLARS OR IMPRISONMENT FOR A TERM NOT EXCEEDING THIRTY DAYS OR BOTH FINE AND IMPRISONMENT.
