## DO HEREBY RESOLVE:

The Council of the Nipissing Band of Indians at a meeting held at Garden Village this Tenth Day of May, 1966, makes the following by-law pursuant to paragraph (h) and (m) of Section 80 of the Indian Act.

## By-Law No. 1

To establish a Community Centre at Garden Village comprised of a skating rink and to carry on a community program of Recreation within the regulations laid down by the Department of Education Act, Ontario.

A committee of 5 persons to be selected, 2 of which must be members of Council. This committee to have full jurisdiction over all recreation programs conducted on the reserve.
