PROVIDING FOR THE ERECTION OF A STOP SIGN AND YIELD SIGN AT INTERSECTIONS

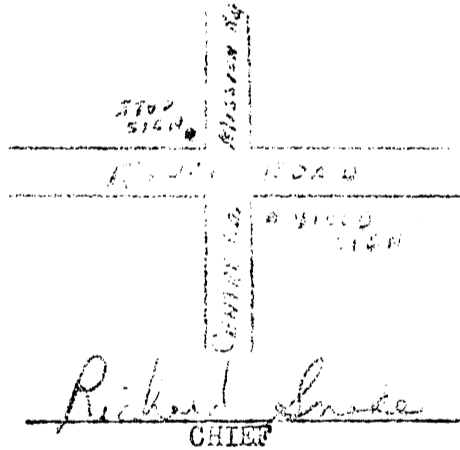
WHEREAS SECTION 65(a) of the Highway Traffic Act (R.S.O. 1960, Chapter 172) provides that the council of a municipality and the trustees of a police village may by by-law approved by the Department provide for the erection of stop signs at intersections on highways under its jurisdiction, and every sign so erected shall comply with the regulations of the Department:

NOW THEREFORE the Council of the Municipality of the Moravian Indian Reserve enacts as follows:

1. (a) The intersection on highways set out in Column 1 is designated as intersection where stop sign shall be erected at the location shown in Column 2.
- (b) The intersection on highways set out in Column 1 is designated as an intersection where yield sign shall be erected at the location shown in Column 2.

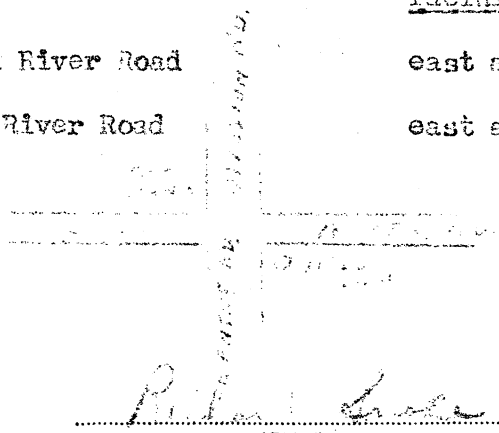
