DO HEREBY RESOLVE:
DÉCIDE, PAR LES PRÉSENTES:

Intoxication By-Law

WHEREAS the Grassy Narrows Band Chief and Council herein reinstates and re-affirms the intoxication by-law passed on or about December 1, 1989 for the Grassy Narrows Reserve;

WHEREAS the Grassy Narrows Band has the authority to ban the sale or possession of intoxicants, for the better preservation of the safety and security of members of the Band of Grassy Narrows Reserve;

WHEREAS, on December 8, 1989, Band Council after considering the contents of this by-law, consented to the contents same.

Definitions

1. For the purposes of this by-law;
 - (a) "Intoxicants" includes solvents, chemicals, alcohol, spirits, vinous, fermented malt or other intoxicating liquor or combination of liquors and mixed liquor a part of which is spiritous, vinous fermented or otherwise intoxicating, preparations or mixtures capable of human consumption that are intoxicating or intended to be used as an intoxicant.
 - (b) "intoxicated" shall have it's ordinary meaning but it shall also include intoxication through the abuse of solvents.
 - (c) "solvent" includes naphtha gas, gasoline, paint thinner, plastic wood, laquer thinner, nail polish remover and other solvents or chemicals used or sniffed for the purposes of obtaining intoxication.
2. No person or persons, while on the Indian Reserve of Grassy Narrows Reserve Band #21, shall;
 - (a) Sell, barter, supply, give, manufacture or transport intoxicants.
 - (b) Be intoxicated through the use of intoxicants.
 - (c) Be found in the possession of any intoxicants.
3. Any person who contravenes the provisions of this by-law is guilty of an offence and liable on summary conviction;

DO HEREBY RESOLVE:
DÉCIDE, PAR LES PRÉSENTES:

3. Any person or persons who contravenes the provisions of this by-law is guilty of an offence and liable on summary conviction;
 - (a) In the case of subsection 2 (a) to a fine not exceeding one thousand dollars (\$1000.00) or to imprisonment for a term not exceeding six months or both and;
 - (b) In the case of subsection 2 (b), (c), to a fine not exceeding one hundred dollars (\$100.00) or to imprisonment for a period not exceeding three months or to both.
4. A police officer shall at any time, without warrant, stop and search any vehicle or other conveyance in which he has reasonable grounds to believe intoxicants are unlawfully kept, and search vehicle and persons therein.
5. Where intoxicants are found by a police officer, under circumstances where it constitutes evidence necessary to prove a contravention of this by-law, the police officer shall seize and take away the intoxicants and packages in which it is kept.
6. A police officer shall arrest without warrant any person whom he finds contravening this by-law.
