DO HEREBY RESOLVE: DÉCIDE, PAR LES PRÉSENTES:

GRASSY NARROWS FIRST NATION BY-LAW RESPECTING CURFEW BY-LAW NO. 1620

WHEREAS paragraphs 81 (1) (c), (d), (q) and (r) of the Indian Act, R.S.C, ch. 1 - 5 empowers the Council of a Band to make by - laws for the observance of law and order, the prevention of disorderly conduct, matters ancillary thereto, and penalty for the violation thereof;

AND WHEREAS the Council of Grassy Narrows First Nation of Indians is of the opinion that a curfew should be established, for the welfare and safety of the children and the community on the reserve;

THEREFORE, the council of the Grassy Narrows First Nation of Indians enacts a by-law as follows:

Short Title

1. This by-law be cited as the "Grassy Narrows First Nation Curfew By-law"

Interpretation

2. In this by law:

"child" means any person who is under the age of 16 years;

"community social event" means a wedding, winter carnival, sports event, religious celebration, or other social event recognized as such by the Council of the Grassy Narrows First Nation

"parent" means a father, mother, tutor, guardian or person having the custody or care in law or in fact of a child:

Page two (2)

"peace officer" means a peace officer as defined in section 2 of the Criminal Code, R.S.C. 1985, c. C-46;

"prohibited hours" means that period of time between the hour of eleven o'clock in the evening of one day and the hour six o'clock in the morning of the following day during the calendar months of June, July, August and September of each year; and between the hour of ten o'clock in the evening of one day and the hour of six o'clock in the morning of the following day during the remaining calendar months of each year;

"reserve" means the Grassy Narrows First Nation Indian Reserve No. 21

Prohibition

- No parent shall permit their child to be in any public place during the 2. prohibited hours unless such child:
 - is accompanied by his parent; A)
 - is accompanied by a person who is eighteen (16) years of age or B) over, with the authorization of that child's parents;
 - is attending or is directly returning home from a community social C) event; or,
 - is authorized by resolution of Council. D)

Powers of the peace officer

3. A peace officer who finds a child who is or, in the absence of evidence to the contrary, appears to be under the age of 16 years, in a public place during the prohibited hours contraty to section 2 may warn such child to immediately return to the child's residence and, if after so warning, the child refused or neglects to return to this residence forthwith, the peace officer may use such reasonable force as is necessary to escort such to the child's residence.

Page three (3)

Meeting with parents

- 4. (1) If, after the warning referred to in section 3 of this by-law, the warning is disregarded by the child, or if the child is found disobeying this by-law a second time within a period of thirty (30) days, the parents of such child may be directed, by resolution of the Council, to meet and discuss the situation with the Council or anyone appointed by the Council through Band Council Resolution for that purpose.
 - A copy of the resolution of the Council referred to in subsection 4(1) shall be sent by first class mail or delivered by hand to the child's parents not less than seven (7) days prior to the proposed meeting.

Penalty

5. A parent who permits his child to be in any public place during the prohibited hours, contrary to section 2, commits an offence and is liable on summary conviction to a fine not exceeding (\$20.00) dollars or imprisonment for a term not exceeding seven (7) days or to both fine and imprisonment.
