RESOLUTION OR BY-LAW NO:

4

Being a By-law to authorize the carrying on of a community program of Recreation within the meaning of the regulations under the Department of Education Act.

1. The Council of the Band enacts as follows:

(a) Pursuant to Regulation 19/66 made under the Department of Education Act, a community program of Recreation is hereby established for the residents of the Reserve.

(b) The said Community Program of Recreation shall be directed, managed and controlled on behalf of the Council by a committee known as the Dokis Band Recreation Committee.

2. The Committee shall be appointed from time to time by the Council as follows:

(a) 2 members of the Council

(b) 3 residents of the said Reserve.

DO HEREBY RESOLVE:

The Council of the Dokis Band of Indians at a meeting held at Dokis Village this Twentieth day of April, 1966, makes the following by-law pursuant to paragraph (h) and (m) of Section 80 of the Indian Act.

By-Law No. 4

To establish a Community Centre at Dokis Village comprised of a Community Hall. A committee of 5 persons to be selected as listed below. This committee to be responsible for carrying out a community program of recreation within the regulations of the Ontario Department of Education Act. This committee to have full jurisdiction over all recreational programs conducted in the Village and to have control of the use of the Community Hall.
