The Council of the Dokis Band of Indians at a meeting held on August 11, 1965, makes the following by-law pursuant to paragraphs (c),(d),(q) and (r) of section 80 of the Indian Act.

## By-law No. 2

A by-law to provide for the regulation of the activities of boys and girls on the Dokis Indian Reserve No. 9 actually or apparently under 16 years of age.

- (a) No boy or girl on the Dokis Indian Reserve No. 9 actually or apparently 16 years of age shall loiter any place within the said Indian Reserve after ten o'clock in the afternoon during the months of the year from July 1st to August 31st inclusive, or after the hour of nine o'clock in the afternoon during the months of September 1st to June 30th inclusive.
- (b) No boy or girl on the Dokis Indian Reserve No. 9 actually or apparently under 16 years of age shall be in any place of entertainment, street, lane, by-way or common within the said Reserve or shall be in the course of returning from any place of amusement off the said Reserve after the hour of ten o'clock in the afternoon during the months of the year from July 1st to August 31st inclusive, or after the hour of nine o'clock in the afternoon during the months of September 1st to June 30th inclusive, unless accompanied with his or her parent or an adult appointed by a person to accompany such child.
- (c) A boy or girl on the Dokis Indian Reserve No. 9 found violating the provisions of paragraphs (a) and (b) may be warned and conducted home by a constable or peace officer.
- (d) Notwithstanding paragraphs (a) and (b) no offence is committed if a boy or girl on the Dokis Indian Reserve No. 9, actually or apparently under 16 years of age, is proceeding unaccompanied directly to or returning unaccompanied directly from a place where supervised activities by an adult are being carried out on Friday or Saturday after the hour of ten o'clock in the afternoon provided that the constable or peace officer has been notified by the supervising adult of the time and place of such activity.
- (a) A parent who permits his child to violate paragraphs (a), (b) and (d) shall be guilty of an offence and shall be liable on summary conviction to a fine not exceeding \$5.00 or imprisonment not exceeding seven days, or to both fine and imprisonment.
