DO HEREBY RESOLVE:

WHEREAS the Council of the CURVE LAKE FIRST NATION desires to repeal certain by-laws;

AND WHEREAS the Council of the CURVE LAKE FIRST NATION, pursuant to sections 80 and 81 of the *Indian Act*,. R.S.C. 1985, c. 1-5, may, subject to the approval of the Minister of Indian Affairs and Northern Development, make by-laws for any or all of the purposes provided for under sections 80 and 81;

AND WHEREAS the Council of the CURVE LAKE FIRST NATION did enact certain bylaws in accordance with aforesaid sections of the *Indian Act*, R.S.C. 1985, c.1-5;
