




Made under Section 81 (f) and 81 (L) and Section 83 (1) (f) being a by-law for the management and upkeep of the Band owned water system and payment of water rates.

(1) No person shall in any way damage any portion of the distribution system of the Couchiching Band water system.

(2) Any person who violates the provisions of Part 1 of this by-law shall be guilty of an offence and shall be liable on summary conviction of a fine not exceeding ten dollars or imprisonment for a term not exceeding seven days or both fine and imprisonment for a term not exceeding seven days or both fine and imprisonment.

(3) That the Band Council shall appoint a manager to maintain and control the water system, and attend to such other duties as decided upon by the council.
