DO HEREBY RESOLVE:

THE FOLLOWING BY-LAW PURSUANT TO PARAGRAPH (b) AND (r) OF SECTION 80 OF THE INDIAN ACT.

BY-LAW NO. 1

A BY-LAW TO PROVIDE FOR THE REGULATION OF TRAFFIC IN THE COUCHICHING RESERVE, IN THE PROVINCE OF ONTARIO.

- (a) NO VEHICLE SHALL BE OPERATED AT A RATE OF SPEED IN EXCESS OF FIFTEEN MILES PER HOUR WITHIN ANY RESIDENTIAL AREA DESIGNATED AND MARKED AS SUCH BY THE COUNCIL OF THE BAND.
- (b) ANY PERSON WHO VIOLATES ANY OF THE PROVISIONS OF THIS BY-LAW SHALL BE GUILTY OF AN OFFENCE AND SHALL BE LIABLE ON SUMMARY CONVICTION TO A FINE NOT EXCEEDING TEN DOLLARS OR IMPRISONMENT FOR A TERM NOT EXCEEDING SEVEN DAYS, OR BOTH FINE AND IMPRISONMENT.
