BEING A BY-LAW TO AUTHORIZE THE CARRYING ON OF A COMMUNITY PROGRAM OF RECREATION WITHIN THE MEANING OF THE REGULATIONS UNDER THE DEPARTMENT OF EDUCATION ACT.

- 1. THE COUNCIL OF THE BAND ENACTS AS FOLLOWS:
 - (a) PURSUANT TO REGULATION 19/66 MADE UNDER THE DEPARTMENT OF EDUCATION ACT, A COMMUNITY PROGRAM OF RECREATION IS HEREBY ESTABLISHED FOR THE RESIDENTS OF THE RESERVE.
 - (b) THE SAID COMMUNITY PROGRAM OF RECREATION SHALL BE DIRECTED, MANAGED AND CONTROLLED ON BEHALF OF THE COUNCIL BY A COMMITTEE KNOWN AS THE COUCHICHING RESPECTION COMMITTEE.
- 2. THE COMMITTEE SHALL BE APPOINTED FROM TIME TO TIME BY THE COUNCIL AS FOLLOWS:
 - (a) 2 MEABERS OF THE COUNCIL
 - (b) 5 RESIDENTS OF THE SAID RESERVE.
