


- 3. This Bylaw comes into full force and effect in accordance with section 82 of the *Indian Act*, R.S.C.1985, c. I-5.

WFN BYLAW NO. 2004-03 – A BYLAW TO REPEAL CERTAIN BYLAWS

WHEREAS Council of the Westbank First Nation deems it expedient to repeal various obsolete bylaws in anticipation of the coming into force of the *Westbank First Nation Self-Government Act*.

NOW THEREFORE the Council of the Westbank First Nation enacts the following bylaw:

1. This Bylaw may be cited as the “*WFN Bylaw No. 2004-03 – A Bylaw to Repeal Certain Bylaws.*”
