By-law 17:176

A BY-LAW TO AMEND BY-LAW 17:176

Section 10 of By-law 17:176 is hereby repealed and the following substituted in its place:

10: A person who violates Section 3,4,5,6,7 or 9 of this by-law is guilty of an offence and is liable on summary conviction to a fine of not more than one hundred dollars, or to imprisonment for a term not exceeding thirty days, or to both fine and imprisonment.





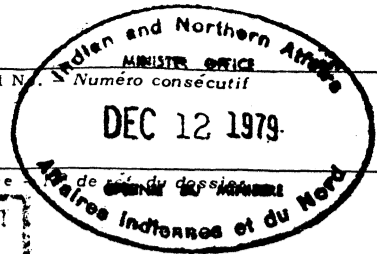
