## BY-LAW NUMBER 14.

BY-LAW TO PROVIDE FOR THE REGULATION OF THE CARRYING OF FIRE ARMS, B.B. GUNS AND PELLET GUNS AND ARCHERY EQUIPMENT, WITHIN THE SAUGEEN INDIAN RESERVE # 29 AND CHIEF'S POINT # 28 OR THE SAUGEEN HUNTING GROUNDS.

- (a) No person other than a Band Member or persons in the company of a Band Member shall carry a fire arm, B.B. guns, pellet guns or archery equipment, within the Saugeen Indian Reserve # 29 and the Chief's Point Reserve # 28 or on the Hunting Grounds.
- (b) No person shall, upon any street or road within the Saugeen Indian Reserve # 29 and Chief's Point Reserve # 28, or Hunting Grounds, discharge firearms, B.B. guns, pellet guns or archery equipment other than in those described by Band Council Resolution.
- (c) Any person who violates the provisions of this by-law shall be guilty of an offence and shall be liable on summary conviction to a fine not exceeding 100 dollars or to imprisonment not exceeding 30 days, or both fine and imprisonment.

Approved and passed at a duly convened meeting of the Council of the Saugeen Band of Indians this third day of November, 1975.
